Social Impact by the Sea

The Actions:

Instating a coastal management academic program

Developing training programs for municipal employees

Establishing coastal innovation hubs in 3 key municipalities

Setting up Smart beach services in underprivileged authorities

Creating a Youth program for Smart Support for Coastal Management

ltem	Estimated Cost per year	Coastal Forum Funding
120 hours training programs municipal employees	\$30,000	\$10,000
MA module on coastal management	\$60,000	\$20,000
Resident Scholar on Smart Coastal Management	\$150,000	
Smart tools for poor authorities	\$50,000 per authority X 6 authorities=300,000	\$25,000 per authority=\$150,000
Smart Support for Coastal youth program	\$10,000 per authority X 22 = 220,000\$ per year	\$2,500 per authority X 22 = \$55,000 per year
Total budget for years	\$829,000	\$310,000
Total budget requested	\$519,000	1
