Course Description and Contents

The course offers an introduction into the foreign policy and external relations of the European Union. It provides insights into a) the legal and institutional framework of the Union's external relations; b) the relationship between the EU's foreign policy and the foreign policy of the member states; c) the different areas of the European Union's external action, such as human rights, trade, or security and defense policy; d) the relations of the EU with major powers and its Eastern and Southern neighbourhood. All course materials including books, articles and PPTs will provided by the instructor before the start of the course.

Course Requirements:

- 1. Attending regularly and participating actively during the classes are highly required. Attendance and active participation will account for 20% of the overall grading.
- 2. Each student should write one **class paper** (2000-2500 words). The essay should be submitted until July 3rd, 2026. For the essays, please select a topic of the presentations in the syllabus at your discretion. It can be the same topic as for your presentation. Criteria for grading are content, structure, and style/ability to use correct English in an academic paper. The essay will account for 40% of the final grade. The essay should be submitted via Moodle.
- 3. Each student should conduct a **presentation** about one of the topics for presentations in the syllabus. You can choose one of the topics in the course outline or suggest a topic for a presentation to the instructor. The length of the presentation should be about 15-20 minutes, for two presenters 30-35 minutes. The presentation will account for 40% of the final grade.
